### **Acceptable Use Policy**

## About this policy

This acceptable use policy sets out the terms between you and us under which you may access this Platform <a href="https://www.ctc.africa">https://www.ctc.africa</a> and subdomains (the "Platform") and any related Clinical Trials Community Platforms. This Acceptable Use Policy applies to all users of, and visitors to, our Platform.

Your use of the Platform means that you accept, and agree to abide by, all the provisions of this Acceptable Use Policy, which supplement the <u>Terms & Conditions</u> for the use of the Platform.

### Information about us

The goal of the CTC is to increase the level of Clinical Trial investments in Africa by increasing the visibility of African clinical trialists and research Platforms as well as making transparent and accessible individual country regulatory and ethics procedures to inform decision making.

The Clinical Trials Community provides a platform for constant engagement among key stakeholders to increase efficiency and promote steady collaborations.

### **Prohibited uses**

You may use the Platform only for lawful purposes. You may not use our Platform:

- In any way that breaches any applicable local, national, or international law or regulation.
- In any way that is unlawful or fraudulent or has any unlawful or fraudulent purpose or effect.
- To harm or attempting to harm minors in any way.

- promote any illegal activity;
- be threatening, abuse or invade another's privacy, or cause annoyance, inconvenience or needless anxiety;
- be likely to harass, upset, embarrass, alarm or annoy any other person;
- be used to impersonate any person, or to misrepresent your identity or affiliation with any person;
- give the impression that they emanate from the AAS, if this is not the case;
- advocate, promote or assist any unlawful act such as (by way of example only) copyright infringement or computer misuse.

## Suspension and termination

The Platform will determine, in its absolute discretion, whether there has been a breach of this Acceptable Use Policy through your use of the Platform. When a breach of this Policy has occurred, the Platform may take such action as it deems appropriate.

Failure to comply with this Acceptable Use Policy constitutes a material breach of the Terms of Use upon which you are permitted to use the Platform, and may result in the Platform taking all or any of the following actions:

- immediate, temporary or permanent withdrawal of your right to use the Platform;
- immediate, temporary or permanent removal of any posting or material uploaded by you to the Platform;
- issue of a warning to you;
